## REGULAR BOARD OF EDUCATION MEETING MINUTES (Thursday, January 28, 2021)

- 1.CALL TO ORDER: The Meeting was called to order at 5:17pm. Directors present were Annie Robbins, Edie Reclusado, Candice Beathard, and Julie LeClair. Frances Longshore had a prior obligation and arrived at 5:35pm. The District Mission statement was read by Ms. Robbins.
- 2. APPROVAL OF AGENDA: A motion was made to approve the agenda as is, by Ms. Reclusado. Seconded by Ms. LeClair. All in favor, motion carried.
