# Revised Narrative Description 4/1/2003

Beginning at a point where an extension of the Mason-Jefferson County line intersects the mid-channel of Hood Canal; thence west along the Mason-Jefferson County line approximately 25 sections to the NW corner of Mason County; thence south following the Mason County line, 18 sections to the SW corner of Sec. 31, TWP 22N R6W; thence east 6 sections; thence south 4 sections; thence east 1 section; thence south 2 sections; thence east 9 sections; thence north 3 sections; thence east 8 sections; thence north 5 sections, more or less, to the mid channel of Hood Canal; thence westerly and northerly along the mid-channel of Hood Canal to the point of beginning.

#### **Director District 1**

Starting at the intersection of southern school district and McReavy Rd in section 17, T21N, R3W. North on McReavy Rd to Bonneville Power Lines in section 6, T21N, R3W. West along Bonneville Power Lines to Skokomish River in section 6, R3W, T20N. North along Skokomish River to Hood Canal and school district boundary. Clockwise following school district boundary to the point of the beginning.

### **Director District 2**

Starting at the intersection of southern school district and McReavy Rd in section 17, T21N, R3W. North on McReavy Rd to Bonneville Power Lines in section 6, T21N, R3W. West along Bonneville Power Lines to Skokomish River in Section 6, R3W, T20N. North along Skokomish River to Hood Canal and school district boundary. West and north following school district boundary through Hood Canal to Finch Creek, in section 12, R4W, T22N. West along Finch Creek to US 101. South on US 101 to Lake Cushman Rd. Westerly on Lake Cushman Rd to Cushman-Potlatch Rd. South on Cusman-Potlatch Rd to Bonneville Power Lines on eastern section line, Section 21, T22N, R4E. South along Bonneville Power Lines to Indian Hill Rd, at the eastern section line of section 33, R4W, T22N. Easterly on Indian Hill Rd to US 101. Southerly on US 101 to school district boundary. North and east following school district boundary to the point of the beginning.

### **Director District 3**

Starting at the intersection of western school district boundary and Olympic National Park Boundary, NW corner, Section 6, T23N, R6W. East, south and east along Olympic National Park Boundary to NFDR 2451, along the southern section line, Section 4, T23N, R5W. Southeast on NFDR 2451 to North Fork of Skokomish River. South along Skokomish River to Lake Cushman. Southeast through Lake Cushman to Cushman Upper Dam Spillway. South along Cushman Upper Dam Spillway to Standstill Dr. Northeast and east on Standstill Dr to Lake Cushman Rd. Southeast on Lake Cushman Rd to Cushman-Potlatch Rd. South on Cushman-Potlatch Rd to Bonneville Power Lines on the eastern section line, Section 21, T22N, R4E. South along Bonneville Power Lines to Indian Hill Rd, at the eastern section line of section 33, R4W, T22N. Easterly on Indian Hill Rd to US 101. Southerly on US 101 to school district boundary. Clockwise following school district boundary to the point of the beginning.

South along Skokomish River to Lake Cushman. Southeast through Lake Cushman to Cushman Upper Dam Spillway. South along Cushman Upper Dam Spillway to Standstill Dr. Northeast and east on Statdstill Dr to Lake Cushman Rd. Southeast on Lake Cushman Rd to US 101. North on US 101 to Finch Creek. East along Finch Creek to school district boundary in Hood Canal, in section 12, R4W, T22N. Counterclockwise following school district boundary to the point of the beginning.
